Background Information About the Workshop

The "Planning for Climate Change" Workshop was developed by the National Estuarine Research Reserves (NERR) System through its Coastal Training Program. The project was funded by the National Oceanic and Atmospheric Administration (NOAA) Coastal Service Center.

The workshop was piloted in two locations in March 2009 in Washington State. It was geared primarily toward shoreline planners, and developed so that Reserves around the country could customize the workshop and use it as part of their educational efforts regarding climate change. While the workshop lays a foundation in science, it primarily focuses on actions that can be taken to prepare and adapt to the anticipated impacts of climate change. To enable other Reserves to offer the workshop, the workshop planning team posted all of the materials, PowerPoint presentations, and streaming video of the piloted workshops at the Coastal Training Program website (<http://nerrs.noaa.gov/Training/padillabay/project.html>).

After receiving interest from local planning agencies about a workshop on planning for climate change impacts, staff from the San Francisco Bay Conservation and Development Commission (BCDC), NOAA Coastal Services Center, San Francisco Bay NERR and the Association of Bay Area Governments (ABAG) collaborated to customize the workshop curriculum to address Bay Area issues and planners' needs. The NOAA Coastal Services Center and SF Bay NERR provided funding to offer these two workshops in Oakland and Sunnyvale.
